As per the regulations notified by the Council vide F.N.I. 37-3/Legal/2004 dated 14 September 2006 and norms, standards, procedures and conditions prescribed by the Council from time to time and based on the recommendations of Appraisal Committee/ Expert Committee, I am directed to convey the extension of approval of the Council to MAHARANA PRATAP ENGINEERING COLLEGE 430, INDRAPURI, SHARDA NAGAR KANPUR, UTTAR PRADESH for conduct of the following courses with the intake indicated below:

The above approval is subject to rectification of the following observations / deficiencies / specific conditions by 31st August 2007.

- ❖ Faculty and proper cadre ratio, requisite qualifications and experience to be appointed in all the disciplines as per AICTE norms.

Note: 1. The mandatory disclosure in prescribed format is not hosted on the website should be hosted by 31st May 2007, failing which, action would be initiated as per the rules and regulations of the AICTE including No Admision/Withdrawal of approval.

The institution is required to submit two copies of the Compliance Report, indicating the rectification of deficiencies along with the details of disclosure and details of faculty recruited for each course in the prescribed format and also give a soft copy on AICTE Website (www.aicte.nic.in) to the concerned Regional Office latest by 31st August 2007 failing which, action of approval beyond the session 2007-08.

The Compliance Report can be submitted along with a processing fee of Rs. 40,000/- in the form of demand draft in the favour of Member Secretary, AICTE, payable at New Delhi. In the absence of processing fee the Compliance Report will not be entertained. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through surprise random inspection without any prior notice.

The above approval granted after rectification of deficiency, would be subject to the fulfillment of the following general conditions:

1. That the management shall provide adequate funds for development of land and for providing related infrastructure, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. (a) That the admission shall be made only after adequate infrastructure and all other facilities are in place as per norms and guidelines of the AICTE.
- (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
- (c) That the curriculum of the course, the procedure for evaluation/assessment of students shall be in accordance with the norms prescribed by the AICTE.
- (d) That the Council shall not allow closure of the Institution or discontinuation of the courses or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
- (e) That no excess admission shall be made by the Institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
- (f) That the institutions shall not have any collaborative arrangement with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
- (g) That the Institution shall not conduct any course(s) in the field of technical education in the same premises/ campus and / or in the name of the Institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
- (h) The institution shall not conduct any non-technical course(s) in the same premises/ campus under any circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.

3. That the institution shall operate only from the approved location, and that the institution shall not open any other branch or unit, centers, extension centers directly or in collaboration with any other institution or any other organization for the purpose of imparting technical education without obtaining permission from the AICTE.
4. That the fees for technical courses shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students' members of students, in any form.
5. That the annual accounts of the institution shall be audited annually by a certified Chartered Accountant and shall be submitted to the Council, the Council or any body, or persons authorized by it.
6. That the Chairman, Principals and the teaching and other staff shall be selected according to procedure, qualifications and experience prescribed by the Council from time to time and pay scales etc as determined by the Council from time to time.
7. (a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure maintenance of administrative and academic standards.
(b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be on the institution's website. The information shall be revised every year with updated information about aspects of the institution.
(c) That it shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
(d) That a compliance report in the prescribed format along with mandatory disclosures on fulfillment of the above conditions shall be submitted each year by the institution within the time limit prescribed by the Council from time to time i.e. 31st August 2007 for the current year.
(e) That if the technical institution fails to disclose the information or suppresses and manipulates the information appropriate action could be initiated including withdrawal of AICTE affiliation.
8. That a laboratory, workshop etc shall be equipped as per the syllabi of the concerned affiliated university, and in the educational condition before making admissions.
9. That a library well furnished with adequate number of titles such as books, periodicals, reference books, etc.
10. That a photocopying center with adequate number of copiers, Printers etc shall be established at the AICTE premises.
11. AICTE shall conduct inspection once in every three years round the year for verifying the status of the institution in terms of administrative, financial and standards.
12. That the AICTE shall conduct inspection with or without notice during the dates specified by the Council for verifying the status of the institution in terms of financial, administrative, standards and practices etc.
13. That the institution shall accept the letter given by Council to the State Government, D.O.T. or State Government.

- 14 That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
- 15 In the event of non-compliance by the MAHARANA PRATAP ENGINEERING COLLEGE 430, INDRAPURI, SHARDA NAGAR KANPUR, UTTAR PRADESH with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that all liabilities arising out of such withdrawal would solely be that of MAHARANA PRATAP ENGINEERING COLLEGE 430, INDRAPURI, SHARDA NAGAR KANPUR, UTTAR PRADESH.
